- Complete Application Packets must include: 1) This application form; 2) Signed and completed Release and Indemnification Agreement; 3) Copy of Liability Insurance, 4) Payment of Market Fee made out to Scarborough Farmers Market Assoc
- **Insurance:** A certificate of insurance for at least \$400,000 must be attached to this application naming the *Town of Scarborough* as an additional insured party for the event dates.
- **Time / Location:** Approximate Farmers' Market vendor space is 20' x 20'. Markets run every **Sunday**, **June** through **October** from 9:00am until 1:00pm. The Market will be held in the Town Hall Parking Lot.
- Parking: Each Farmers' Market vendor will be entitled to at least one designated parking spot.
- Set-up may begin at 7:30 am
- Completion: Your Farmers' Market vendor space must be vacated and cleaned up by 3:00pm on the day of each market.
- Electricity: There will be no electricity available to Farmers' Market vendors.
- Fee: The market fee of 75 dollars is to be collect from new vendors, returning vendors shall provide a market fee of 20 dollars to spend on continuous marketing projects for the Farmers Market.
